

RELEASE OF LIABILITY AND INDEMNITY AGREEMENT

The undersigned parents and/or guardians (collectively, the "Parents") of \_\_\_\_\_ (the "Minor Child") understand and assume the risks of having the Minor Child participate in a tour with Aaron Cantrell and College Trips of

1. The Activity will involve travel by charter bus to and from various college campuses, touring the colleges and environs, and staying overnight at a hotel, all of which involves certain risks. These risks include but are not limited to the following: the risk that the student will: become involved in a highway accident, suffer injury while touring, or engage in illegal or unsafe activities or become separated from the Activity. Accordingly, the Parents hereby expressly acknowledge and agree as follows:

2. The Parents, who hereby represent that they are the guardians of the Minor Child, intend to and do hereby, for themselves and their Minor Child, release, forever hold harmless and waive any claims to the following persons and entities for injury, death, or property damage, including attorneys' fees and court costs, for any accident or negligent act or omission relating to or occurring to the Minor Child during his/her attendance at the Activity: Aaron Cantrell, Maria Carroll, Paso Robles Joint Unified School District, College Trips, College Trips.com, and their owners, directors, officers, agents, representatives, employees and volunteers (collectively, the "Released Parties").

3. The Parents expressly agree to fully indemnify and hold harmless the Released Parties from any suit, claim or liability, including attorney fees and court costs, by any third party, including, but not limited to, the Minor Child, for any injury, death or property damage to any third party or the Minor Child that arises from the negligent and/or grossly negligent acts or omissions of the Released Parties or the undersigned Minor Child.

4. The Parents agree that Aaron Cantrell may unilaterally cancel the Minor Child's right to participate in the Activity without refund for any of the following actions: any illegal activity, any threatening or abusive behavior, any possession or consumption of alcohol, tobacco, or other drugs, a violation of the announced curfews and meeting times, an engagement in unsafe practices including leaving the hotel, any unauthorized visiting of other hotel rooms besides that assigned to the Minor Child, or a failure to travel with a designated partner(s) (collectively, the "Violations"). Should the Minor Child commit any of the above Violations or otherwise behave in a manner deemed improper by Aaron Cantrell in his sole and absolute discretion, Parents agree to retrieve the Minor Child from the Activity immediately upon the request of Aaron Cantrell or to pay for the cost of transporting the Minor Child back home should Aaron Cantrell determine that transport by a third party is preferable, in his sole and absolute discretion. The Parents further release and agree to indemnify and defend Aaron Cantrell, Maria Carroll, Paso Robles Joint Unified School District, College Trips and their heirs, employees, and beneficiaries from any liability arising from any Violations committed by the Minor Child.

5. Any controversy or claim arising out of or relating to this contract, or the breach thereof, shall be settled by arbitration administered by the American Arbitration Association in accordance with its Commercial Arbitration Rules (including the Emergency Interim Relief Procedures) and judgment on the award rendered by the arbitrator(s) may be entered in any court having jurisdiction thereof.

6. In consideration for participation in the Activity, I hereby grant permission for College Trips to use for promotional purposes images taken of Minor Child during a tour. \_\_\_\_\_: Initial here if you do not want your Minor Child's images used for promotional purposes.

7. The Parents acknowledge that they have had, prior to signing below, the opportunity to carefully review, read, and clarify any questions they might have pertaining to this Release. The Parents hereby acknowledge that they have read and understand the legal and binding effect of this Release, and expressly agree to be bound herby now and at all times in the future.
